### READING OF NOVEMBER $6^{TH}$ 2011GENERAL MEETING MINUTES HELD BY THE ETAMETITE FAMILY:

Abamwa, Lucky raised the issue of the collection and the mode of presentation of the money collected to the family. The president told the house that all monies collected would be paid into ODIA's account and a check would be issued to them for the amount collected. The sum of \$750 was raised as follows:
