After reading out the requirements of the various banks Anighoro, Julius saw the possibility of opening the account. On his part Paul Emadu, suggest CHASE as first choice as their requirements are direct and clear. There was no objection to this choice. A second suggestion of Citibank was made by Julius Anighoro, but was declined for Bank of America suggested by the president and supported by Flora Okifo.

Free checking account was agreed to be open in any of the two choice banks.

Similarly, 501c preparation was suggested by the president, supported by Paul Emadu, with an advice to checked further for a cheaper rate of preparation.

CONSTITUTIONAL REVIEW

To quicken the review of the constitution, Julius Anighoro, suggest we set up a group to review the draft and present it to the house for adoption. Osio, Etanomare suggested same group review but Paul Emadu, and Etametite, Peters sees this as going thru same process as the house will also review the work of the group before adoption instead the review should be done by the general house. Okifo, Godwin spoke of the importance of the earlier call on members to do a review prior to any meeting come with their inputs as a way forward. Curious to know Paul Emadu asked of the origin of the draft. He was told in reply by the president that the house mandated the executives to come out with a draft constitution for association which they did and presented to the house that we are now reviewing. The president blamed all for the delay of the review of the draft constitution and reminded the house that the executives have one meeting more to the end of their tenure and would have been good if the review is completed under the dispensation. Paul Emadu, volunteer to lead the review process so as the work.

On the review work chapter 6 was completed and chapter 7 was taken half way before the secretary general moved for the adjournment of the meeting, seconded by Paul Emadu, and supported by Julius Anighoro.

Members were once again advice to come to the next meeting of May 1st, 2011 with their inputs to quicken the review.
